Funds

An invoice of €1.000,- was sent to Stichting Sanssouci for the production of 'The Addams Family'.

Sponsoring

Revenue of €54,48 made through Sponsorkliks was paid out to the bankaccount.

Unforeseen Income

Interest from the savings account has been deposited into the account. Next to that, the board of 'The Addams Family' won second place in the More Than a Degree Awards. The prize money of €200,- was paid to the InSPE checking account.

Expenses

The following expenses were made in the financial year 2023-2024:

License Costs

For the upcoming production of 'The Prom' a deposit of €1.605,- was made for the renting costs of the materials. Next to that, InSPE paid €242,- for agency costs to Grand Circle Academy.

Board Costs

The board of 2024-2025 bought board clothing to be recognizable during the project period.

Unforeseen Expenses

A money box for the cash was bought for €5,95.

Assets

- There is still one debtor from the Addams Family performance.
- There is still one participant who needs to pay the participation fee for The Addams Family.

Liabilities

- The reservations are for continuity of InSPE and expected running costs, like costs for the bank account and webhosting. Due to an accounting mistake, the opening balance for the running costs had to be readjusted to a lower amount.

- A reservation still exists for the payment of the previous choreographer, who has yet to submit an invoice for both Fiddler on the Roof, and The Addams Family. InSPE is legally obligated to keep the money available for 5 years after the invoice deadline has passed.
 - The deadline for the Fiddler money is: 20 October 2026.
 - And for The Addams Family: 4 July 2028.

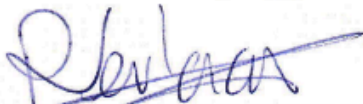

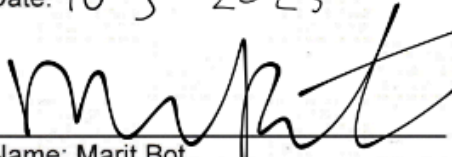

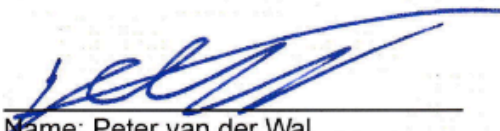
